2. Rule 2.05 Subsection (G) is being added to require an email address be provided for each current officer and director of the Charitable Organization in the renewal filing. This addition will help the Charities Division in trying to contact board officers.

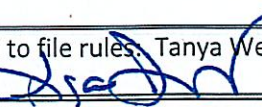
