RESOLUTION

WHEREAS, it is necessary for the Occupational Licensing Review Commission to issue a resolution regarding the approval or denial of specific rules submitted for its review: NOW, THEREFORE, LET IT BE RESOLVED BY THE OCCUPATIONAL LICENSING REVIEW COMMISSION, that the following rules shall be known to have been approved by the Commission at a duly called meeting of its members on June 26, 2025, and may now be filed as final with the Secretary of State's Office for inclusion in the Mississippi Administrative Code:

- Mississippi Board of Nursing – Title 30 Miss. Admin. Code, Pt. 2870, Rule 1.1: *Definition of Terms*– Amend existing rule to define gratuitous nursing. Title 30 Miss. Admin. Code, Pt. 2810, Ch. 1, Rule 1.12: Initial and Re-examination Applicants' Qualifications and Timeframes–Amendment to existing rule to clarify the qualifications and timeframes regarding licensure for applicants. Title 30 Miss. Admin. Code, Pt. 2840, Ch. 1 Rule 1.5(E): *Prescribing Controlled Substances and Medications by APRNs/Use of Diet Medications*- Amendment to existing rule create an avenue to assist providers in meeting the medical needs of their patients in terms of weight loss treatment.
- Mississippi Board of Pharmacy – Title 30 Miss. Admin. Code, Pt. 3001, Article LI: *Ambulatory Pharmacists to Ambulatory Surgery Centers and Multi-Provider Clinics* – Amendment to existing regulation outlining the responsibilities of consultant pharmacists who advise ambulatory surgery centers and multi-provider clinics to clarify that the new name of the role of the pharmacist is "advisory." Title 30 Miss. Admin. Code, Pt. 3001, Article L: *Ambulatory Surgery Centers and Multi-Provider Clinics* – Amendment to existing regulation regarding ambulatory surgery centers and multi-provider clinics to clarify that the pharmacist assisting is in an advisory capacity. Title 30 Miss. Admin. Code, Pt. 3001, Article XLII: *Administrative Procedures*– repeal of a rule no longer needed. This language has been incorporated into another rule previously approved by the OLRC so there would only be one rule outlining the administrative procedures of the MS Board of Pharmacy.
