The amendment to Regulation 57 would amend section 104 to insert additional information that may be disclosed to participating PERS employers. PERS may disclose information necessary for proper enrollment in retirement plans administered by PERS and information necessary for compliance with Governmental Accounting Standards Board (GASB) reporting.
