The amendment to Regulation 61 would amend section 101 to insert PERS Tier 5 retirement eligibility and acknowledge the closing of the Supplemental Legislative Retirement Plan to new employees as of March 1, 2026, and the closure of the Municipal Retirement Systems as of July 1, 1987.
