Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: The filing of the proposed rules will create regulations in adherence to 2023 Mississippi House Bill 2343 amending Mississippi Code Annotated 45-1-19 requiring the written authorization of the Chief of Capitol Police or the Commissioner of the Department of Public Safety prior to the approval of any event which is to take place on any street or sidewalk immediately adjacent to any building or property owned or occupied by any official agency, board, commission, office or other entity of the State of Mississippi.
