Short explanation of rule/amendment/repeal and reason(s) for proposing rule/amendment/repeal: This Administrative Code is being revised to remove Chapter 6 and to correspond with the 1915(c) Independent Living Waiver, Assisted Living Waiver and Traumatic Brain Injury/Spinal Cord Injury Waiver approved by CMS, and includes the following revisions: Updates to provider qualifications and requirements, updates to quality metrics to align as much as possible with all HCBS waivers, updates to case management service specifications and provider qualifications, add new medication management and environmental safety services, update language regarding the provision of services by family members and define legally responsible persons.
