



## Proposed initiative

THIS PROPOSED INITIATIVE, PETITION THE STATE GOV'T TO LET THE WHOLE STATE OF MISSISSIPPI, AN AGRICULTURE STATE EXERCISE IT'S CONSTITUTIONAL RIGHTS TO "FORM A MORE PERFECT UNION" FOR THE BEEFIT OF ALL. THE U.S. CONSTITUTION AND THE MS. CONSTITUTION OF 1890 GIVES THE WHOLE STATE OF MS. THAT CONSTITUTIONAL RIGHTS:

### AMENDMENTS:

5th: TO BRING A "PRESENTMENT" OR "INDICTMENT" MEANS TO FORMALLY CHARGE A PERSON(S) WITH COMMITTING A CRIME. THE RESEARCH FINDING REPORT FROM THE UNIVERSITY OF MS (OXFORD) WITHHELD IMFORMATION FROM IT'S CITIZEN THAT WILL SAVE LIVES, PROTECT FROM DANGER, PREVENT HIGH DEATH RATE IN HEART DISEASE, CANCER, MENTAL ILLNESS AND ADDICTIONS, OBESITY, AND PROVERTY.

7th: IN SUITS AT COMMON LAW, WHERE THE VALUE IN CONTROVERSY SHALL EXCEED TWENTY DOLLARS, THE RIGHT OF TRIAL BY JURY SHALL BE PRESERVED AND PROVIDED FOR, BUT CUSTOMARILY, FEDERAL COURTS DO NOT HEAR CIVIL CASES UNLRSS THEY INVOLVE A GOOD DEAL MORE MONEY.

THE U.S.A SPENDS OVER BILLION OF DOLLARS PER YR. ON PRODUCTS MADE FOR CANNABIS FROM OTHER COUNTRIES (SOME OF THE COUNTRIES USA IS NOW IN WAR WITH) CHINA BEING ONE OF IT'S LARGEST TRADE. SINCE 1968 UNIVERSITY OF MS RESEARCH ON THE CANNABIS PLANT

FAMILY. THIS UNIVERSITY IS THE LARGEST MANUFACTURER AND DISTRIBUTOR OF THE CANNABIS FAMILY IN THE NATION, ALSO THE MOST CHARITABLE IN THE NATION.

9<sup>TH</sup>: POWERS RESERVED TO THE PEOPLE, WE THE PEOPLE OUR RIGHTS ARE NOT LIMITED TO THOSE MENTIONED IN THE CONSTITUTION. WE THE PEOPLE HAVE THE RIGHT TO KNOW THE REPORT FINDING FROM THE RESEARCH OF UNIVERSITY OF MS(OXFORD) CANNABIS SINCE 1968 TO FDA, USDA, MS' CITIZEN AND STATE GOV'T.

10<sup>TH</sup>: POWERS RESERVED TO THE STATE PROTECTS THE STATE AND THE PEOPLE FROM AN ALL-POWERFUL FEDERAL GOV'T. IT PROVIDES THAT THE STATE OR THE PEOPLE RETAIN ALL POWERS EXCEPT THOSE DENIED THEM OR THOSE SPECIFICALLY GRANTED TO THE FEDERAL GOVERNMENT. THIS "RESERVED POWERS" PROVISION IS A CHECK ON THE NECESSARY AND PROPER POWER OF THE FEDERAL GOV'T PROVIDED IN THE "ELASTIC CLAUSE" IN ARTICLE 1 SEC 8 CLAUSE 18.

THE FEDERAL GOV'T LIMITED RESEARCH OF THE CANNABIS PLANT FAMILY TO THE UNIVERSITY OF MS(OXFORD) SINCE 1968 CAUSING ESTABLISH AGRICULTURE UNIVERSITY AND SCHOOLS(ESPECIALLY AFRICAN-AMERICAN) TO SLOWLY DETERIORATE, CAUSING NO FUNDS FOR RESEARCH AND THEM TO LOSE THEIR CREDITABILITY, MONEY AND ENROLLMENTS.
