# GETTING STARTED

## MAKE YOUR PLAN

- **Who?** Recruit reliable volunteers to help you plan and conduct the registration drive.
- **What?** Encourage eligible Mississippians to register to vote regardless of party affiliation. For eligibility information, consult the Voter Registration Guide ([page 7](#)).
- **When?** Decide a day and time for the event.
- **Where?** Choose a busy location where you are likely to interact with a wide range of people.
- **Why?** Because voting is one of our greatest civil liberties and the best way to let our voices be heard!

### Remember:

- **Start Early.** It's never too soon to start planning. Figure out the items you need and what you can check off your list early.
- **Get Connected.** Use social media to spread the word and show off your voter registration success. Use the hashtag #YallVote.
- **Ask for Help.** Do not hesitate to reach out for assistance or guidance.

- **Stay Nonpartisan.** You are not there to tell people who to vote for but to help them complete the voter registration process.
- **Have fun!**

- Pens.
- A table and chairs.
- List of volunteers.

- Signage for the table and the facility where you are holding your event.


## CHECKLIST

# VOLUNTEER EDUCATION

Once you have confirmed volunteers for your voter registration drive, educate them on the process and what their role will be on the day of your event.

**Be sure to review the following:**

- The Voter Registration Application ([page 8](#)) located on the Mississippi Secretary of State's website under the [Elections Division](#).
- How to properly complete a registration form including all required fields.
- Be aware of common mistakes, such as forgetting to sign the form.
- The sample question/answer document ([page 6](#)), and contact information for questions that go beyond the content provided in this toolkit.
- What to do with completed registrations.
- The Mississippi Elections Calendar (opposite page).

**TIPS FOR TALKING TO VOTERS:**

- **BE FRIENDLY!**  
Think about how you would want someone to speak to you during this process.
- **BE IMPARTIAL!**  
Remember, you are not telling people who to vote for, only how to register to vote.
- **BE ENCOURAGING!**  
Reassure each person about the importance of making their voice heard!

# AFTER THE EVENT

## Upon completion of your voter registration event:

- Gather all materials and place all completed registration applications in an envelope.
- Deliver completed registration applications to the appropriate Circuit Clerk offices. Locate the mailing address for each Circuit Clerk Office in the online directory located in the [Publications Division](#) on the Mississippi Secretary of State's website.
  - Note--Registration forms must be received or postmarked 30 days before the date of an election. If the 30th day falls on a Sunday or legal holiday, then both the postmark and in-person deadline are extended to the next regular business day.
  - For questions, contact the Elections Hotline at the Office of the Secretary of State at 1-800-829-6786.
- Be sure to thank your volunteers for assisting. A personal touch like a phone call or hand-written note can have a huge impact and exemplify your appreciation for their time.

## CHECKLIST

### Use the following checklist to help you after your event:

- ✓ Are all applications complete?
- ✓ Are you aware of the deadline to submit completed applications?
- ✓ Do you know where to deliver completed applications?
- ✓ Have you thanked volunteers?



# FREQUENTLY ASKED QUESTIONS

## *Q. What personal information is needed to register to vote?*

A. All that is needed is a driver's license number or the last four digits of a social security number.

## *Q. I am 17 years old but will be 18 by Election Day. Can I still register?*

A. Yes. A person may register to vote early if they turn 18 on or before Election Day. Also, a person who is 17 but will be 18 on or before General Election Day can register to vote in a primary election.

## *Q. Is a voter registration drive just for registering new voters?*

A. No! Already registered voters may also update their registration information including name change and/or address change.

## *Q. Can this form be filled out for someone else?*

A. No. A valid signature of the person registering to vote is required.

## *Q. Does a person have to fill out the application on the day of the voter registration drive?*

A. No. The registration application can be completed at a later date as long as it is postmarked, or hand delivered to the Circuit Clerk's Office located in the county in which they are trying to register no later than 30 days before an election.

## *Q. How can we promote the event?*

A. There are many ways to promote your event. A few of the most effective are utilizing social media, signage, and don't underestimate word of mouth. Be sure people understand it is just voter registration and not a political event.

## *Q. Can we use the Secretary of State's logo and/or pictures of Secretary Michael Watson for promotion?*

A. Agency logos and photos of Secretary Watson are reserved for official partnerships. Contact our External Affairs Division at [ExternalAffairs@sos.ms.gov](mailto:ExternalAffairs@sos.ms.gov) to get more information on if you are eligible to become an official partner.

# HOW TO REGISTER TO VOTE

## REGISTRATION QUALIFICATIONS

Every U.S. citizen who possesses the following qualifications is eligible to register to vote in Mississippi:

- A resident of Mississippi and the county, city, or town for 30 days prior to the election;
- At least 18 years old (or will be 18 by the date of the next General Election);
- Not declared mentally incompetent by a court; and
- Not convicted of a disenfranchising crime as defined by Section 241 of the Mississippi Constitution or by Attorney General Opinion, unless pardoned, rights of citizenship restored by the Governor or suffrage rights restored by the Legislature.

## REGISTERING BY MAIL

Mail-In Registration Applications may be downloaded from our website at [yallvote.ms](http://yallvote.ms). Please follow the instructions on that website for sending in registration applications by mail to the Circuit Clerk in the county of your residence. You must include a copy of a current and valid photo ID or a copy of a current utility bill, bank statement, government check, paycheck or other government document that shows your name and address.

## REGISTERING IN PERSON

You may register to vote in person at any of the following locations:

- Circuit Clerk's Office;
- Municipal Clerk's Office;
- Department of Public Safety; or
- Any state or federal agency offering government services, such as the Department of Human Services.

## REGISTRATION DEADLINE

You must register to vote 30 days before the date of the election. If the 30th day falls on a Sunday or legal holiday, then both the postmark and in-person deadline is extended to the next regular business day. Voters who have not yet reached the age of 18 at the time of the primary election may vote in the primary election so long as he/she will reach the age of 18 on or before the date of the general election.

## WHERE TO VOTE

After registering to vote, your Voter Registration Card will be sent to your residence/ mailing address provided on your application. Your Voter Registration Card will provide the name, location and number of the precinct in which you will vote.

## VOTING WITH PHOTO ID

All Mississippi voters casting a ballot in person at the polls or casting an absentee ballot in the Circuit or Municipal Clerk's Office must present an acceptable photo ID. See [Voter ID | Michael Watson Secretary of State \(ms.gov\)](#) for additional information. If you do not present an acceptable form of photo ID or are unable to do so because of a religious objection, you are entitled to cast an affidavit ballot. Call 1-800-MSVoter (1-800-678-6837) for Voter ID information or assistance in obtaining a Mississippi Voter Identification Card.

# MISSISSIPPI MAIL-IN VOTER REGISTRATION APPLICATION

- You can use this form to: register to vote in Mississippi or change your name and/or address.
- If you are registering for the first time in Mississippi and DO NOT have a Mississippi driver's license or social security number, you must send with this application a copy of a current and valid photo ID or a copy of a current utility bill, bank statement, government check, paycheck or other government document that shows your name and address in this county.
- An application for voter registration must be postmarked or hand delivered to the Circuit Clerk's Office located in the county of your voting residence no later than 30 days before an election.
- You may not register to vote if you have been convicted in a Mississippi state court of any of the following crimes: voter fraud, murder, rape, bribery, theft, arson, obtaining money or goods under false pretense, perjury, forgery, embezzlement, bigamy, armed robbery, extortion, felony bad check, felony shoplifting, larceny, receiving stolen property, robbery, timber larceny, unlawful taking of a motor vehicle, statutory rape, carjacking or larceny under lease or rental agreement.
- If you live in an area without house numbers or street names, please include a drawing of your location to enable us to identify your appropriate voting precinct.
- Photo ID Required to Vote: You will be required to present an acceptable form of photo identification when you vote at your polling place on Election Day or by absentee ballot in your Circuit Clerk's Office, unless exempted by law. ## **VOTER DECLARATION- Read and Sign**

I swear/affirm, under penalty of perjury, that:

- I am a U.S. citizen.
- I will be 18 years of age on or before the next general Election Day.
- I am a resident of Mississippi, this county and this city for at least 30 days.
- I have not been adjudicated as mentally incompetent.
- I have never been convicted of voter fraud or any other disenfranchising crime OR, if convicted, I have had my voting rights restored as required by law.
- The address listed above is my legal place of residence.

**WARNING:** Giving false information to register to vote is a felony punishable by a fine of not more than \$5,000 or imprisonment for not more than 5 years, or both. Miss. Code Ann. § 23-15-17.
