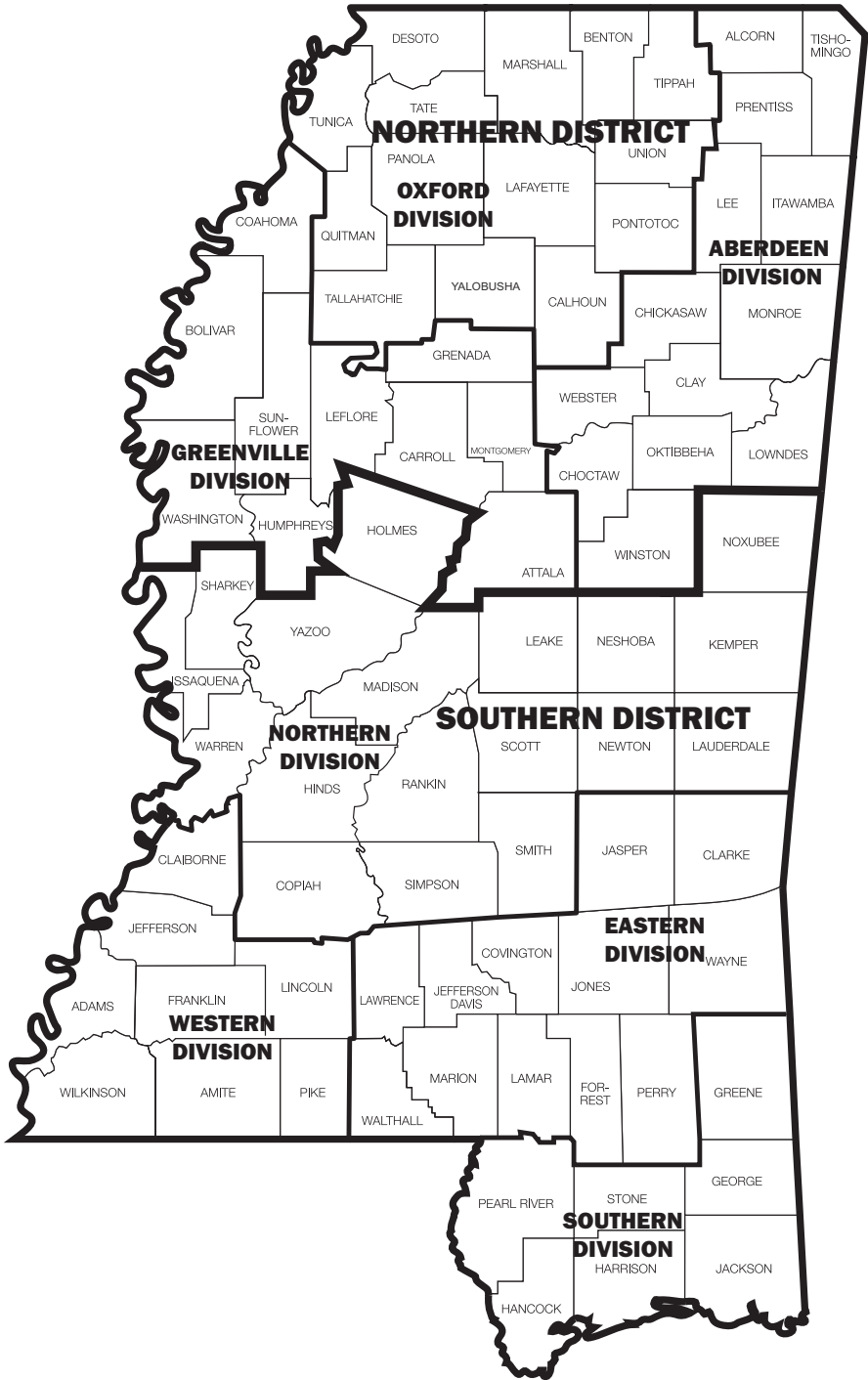

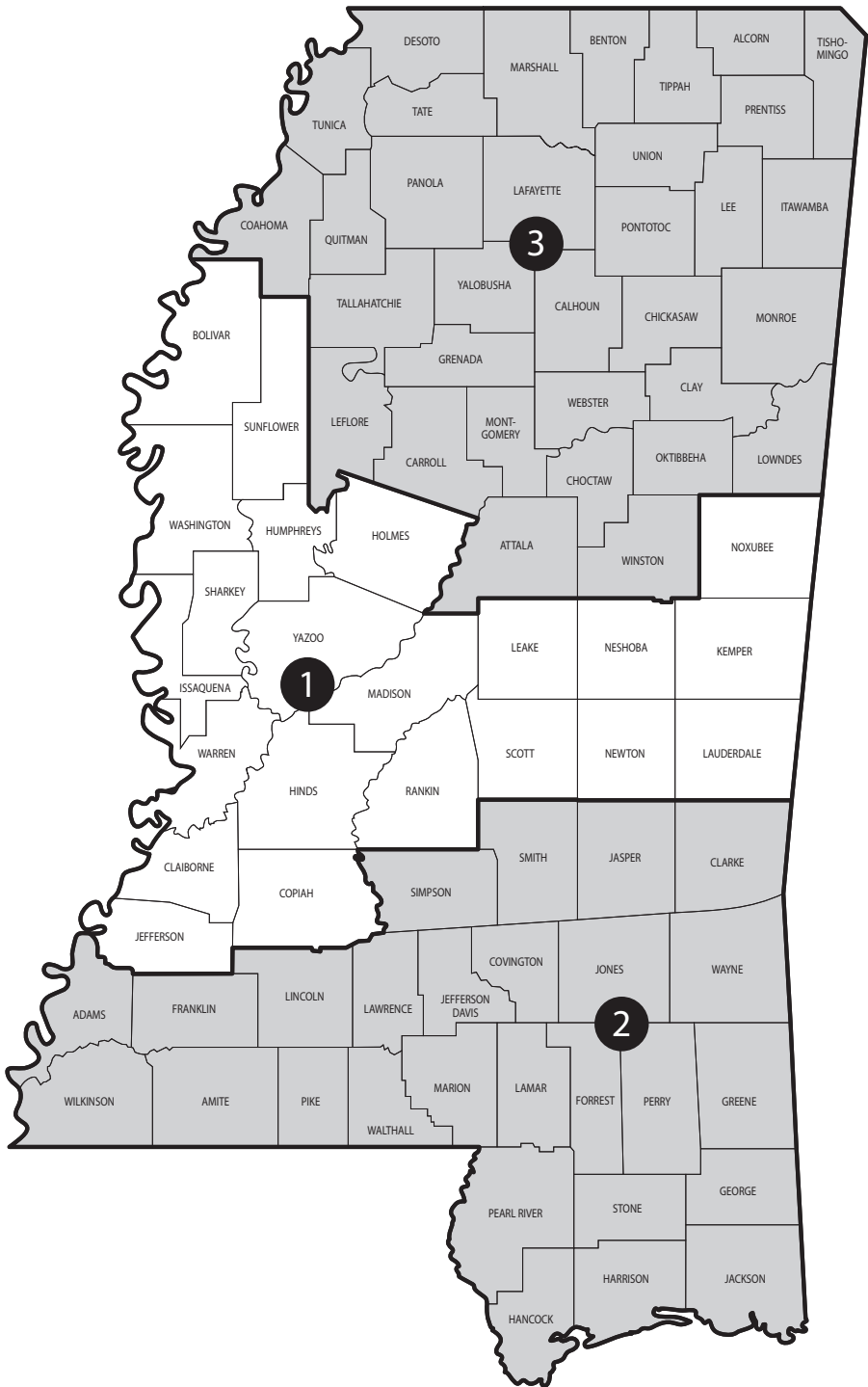

Terms of Court. Mississippi Code Annotated 1972, Section 9-3-3. A term of the Supreme Court shall be held twice each year in the city of Jackson, to be styled the Supreme Court; and the terms shall commence the second Monday of September and the first Monday of March, and the court shall be kept open for the discharge of business for at least nine months of every year if the business therein should require.

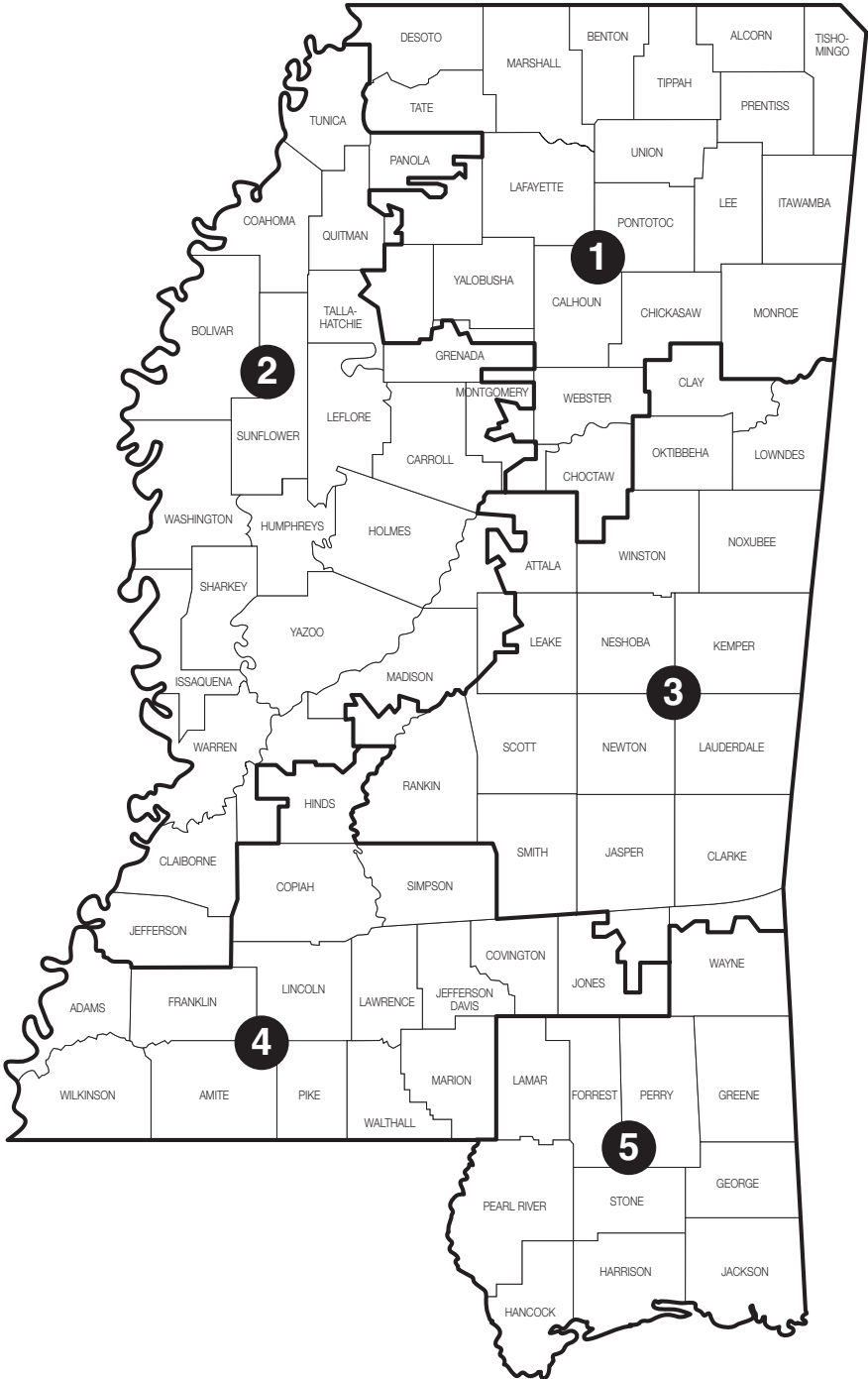
