IMPORTANT

- (1) Pre-Election Reports are mandatory if the committee has received any contributions or made any expenditures in support of, or in opposition to, a 2020 special election candidate appearing on the June 23, 2020 special election or July 14, 2020 runoff ballots.
- (2) Annual Reports are mandatory unless a Termination Report is filed prior to December 31, 2020.
- (3) Until a committee files a Termination Report, annual and pre-election reports must be filed in accordance with Miss. Code Ann. § 23-15-807 (b) (ii) and (iii).
- (4) The Secretary of State must be in actual receipt of the required reports by 5:00 p.m. on the deadline. If the deadline falls on a weekend or a holiday, the office must be in actual receipt of the required reports by 5:00 p.m. on the first working day *before* the deadline. No candidate who is elected to office shall receive any salary or other remuneration for the office unless and until he files all reports required by statute. Miss.
