IMPORTANT

- (1) Pre-Election Reports are mandatory if the committee has received any contributions or made any expenditures in support of, or in opposition to, a 2020 special election candidate and/or ballot measures appearing on the November 3, 2020 special election or November 24, 2020 runoff ballots.
- (2) Annual Reports are mandatory unless a Termination Report is filed prior to December 31, 2020.
- (3) Until a committee files a Termination Report, annual and pre-election reports must be filed in accordance with Miss. Code Ann. § 23-15-807 (b) (ii) and (iii).
- (4) The Secretary of State must be in actual receipt of the required reports by 5:00 p.m. on the deadline. If the deadline falls on a weekend or a holiday, the office must be in actual receipt of the required reports by 5:00 p.m. on the first working day *before* the deadline. No candidate who is elected to office shall receive any salary or other remuneration for the office unless and until he files all reports required by statute. Miss. Code Ann. §§ 23-15-811 and 813 (1972).
