SUBJECT: Required Elections Training Sessions for County Party Executive Committees

The Secretary of State's Office is committed to the idea that elections are a team effort. No one person should ever have to navigate the process of implementing an election on their own. We strive to see that you are well prepared in serving your constituents and ours.

Pursuant to Miss. Code Ann. § 23-15-211(4) the Secretary of State's Office will host elections training for the chairperson of each county party executive committees, or his or her designee. The chairperson, or his or her designee, of each county party executive committee is <u>required to attend</u> <u>unless</u> the executive committee enters a contract with the county election commissioners. Our office will issue a certificate of training to all attendees upon completion of this training. The certificate will state the officials' are qualified to conduct the Primary Election in 2022.

Please be advised that, to limit the risk of COVID-19, we are limiting our training to only two (2) people from each executive committee.

Our office will host four (4) total training sessions. The date and location of each training is as follows:
