

## **2025 Campaign Finance Reporting Schedule**

2025 candidates and the political committee(s) supporting or opposing these 202 candidates must file campaign finance disclosure reports in accordance with the following schedule for the time periods specified below:

**Tuesday, January 10, 2025**.....**Periodic Report**

Judicial Candidates

**Wednesday, January 31, 2025**.....**Annual Report**

(January 1, 2024, through December, 31, 2024)

All candidates and all Political committees that

received or made

Expenditures in Mississippi during 2024.

**Termination Report** - Required by *all* candidates and *all* political committees in order to end reporting obligations. To be eligible for termination, the candidate or committee must no longer be soliciting contributions, no longer making campaign disbursements, nor have any outstanding debts or financial obligations.

Authority: Miss. Code Ann. §23-15-801, et. seq.

Penalties: Failure to timely submit required reports in accordance with the applicable statute(s) may result in the imposition of a civil penalty in the amount of \$50 per day for ten (10) days and/or prosecution pursuant to Miss. Code Ann. §§ 23-15-811 and 813 (1972).

## **2025 County General/Special Election Reporting Schedule**

2025 Candidates for County General/Special Election and political committee(s) supporting or opposing these candidates or county local option elections or referenda must file campaign finance reports in accordance with the following schedule for the periods specified below:

**October 28, 2025**.....**Pre-Election Report**  
(January 1, 2024 through October 26, 2025)

**November 18, 2025**.....**Pre-Runoff Election Report**  
(October 27, 2025 through November 16, 2025)

**January 30, 2026**.....**Annual Report**  
(January 1 2025 through December 31, 2025)

## **2025 Municipal Election Reporting Schedule**

2025 Candidates for Municipal Election and political committee(s) supporting or opposing these candidates must file campaign finance reports in accordance with the following schedule for the periods specified below:

**March 25, 2025**..... **Pre-Election Report**  
(January 1, 2024, through March 23, 2025)

**April 15, 2025**..... **Pre-Runoff Election Report**  
(March 24, 2025, through April 13, 2025)

**May 27, 2025**..... **Pre-Election Report**  
(January 1, 2025, through May 25, 2025)

**January 30, 2026**..... **Annual Report**  
(January 1, 2025, through December 31, 2025)

## **2025 Redistricting Special Election Reporting Schedule**

2025 Candidates for Redistricting Special Election and political committee(s) supporting or opposing these candidates must file campaign finance reports in accordance with the following schedule for the periods specified below:

**July 29, 2025**..... **Pre-Election Report**  
(January 1, 2024, through July 27, 2025)

**August 26, 2025**..... **Pre-Runoff Election Report**  
(July 28, 2025, through August 25, 2025)

**October 28, 2025**..... **Pre-Election Report**  
(January 1, 2025, through October 25, 2025)

**January 30, 2026**..... **Annual Report**  
(January 1, 2025, through December 31, 2025)
