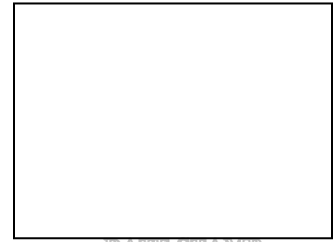

**IMPORTANT**

- (1) Pre-Election Reports are mandatory if the committee has received any contributions or made any expenditures in support of, or in opposition to, a 2023 special election candidate appearing on the January 10, 2023 special election or January 31, 2023 runoff ballots.
- (2) Annual Reports are mandatory unless a Termination Report is filed prior to December 31, 2023.
- (3) Until a committee files a Termination Report, annual and pre-election reports must be filed in accordance with Miss. Code Ann. § 23-15-807 (b) (ii) and (iii).
- (4) The Secretary of State must be in actual receipt of the required reports by 5:00 p.m. on the deadline. If the deadline falls on a weekend or a holiday, the office must be in actual receipt of the required reports by 5:00 p.m. on the first working day before the deadline. Reports may be hand delivered to 401 Mississippi Street, Jackson, MS; mailed to P.O. Penalties: A candidate who fails to file, or fails to timely file, required reports in accordance with the statutory deadline cannot be certified as elected to office unless and until he files all reports due as of the date of certification. No candidate who is elected to office shall receive any salary or other remuneration for the office unless and until he files all reports required by statute. Miss. Code Ann. §§ 23-15-811 and 813 (1972).
