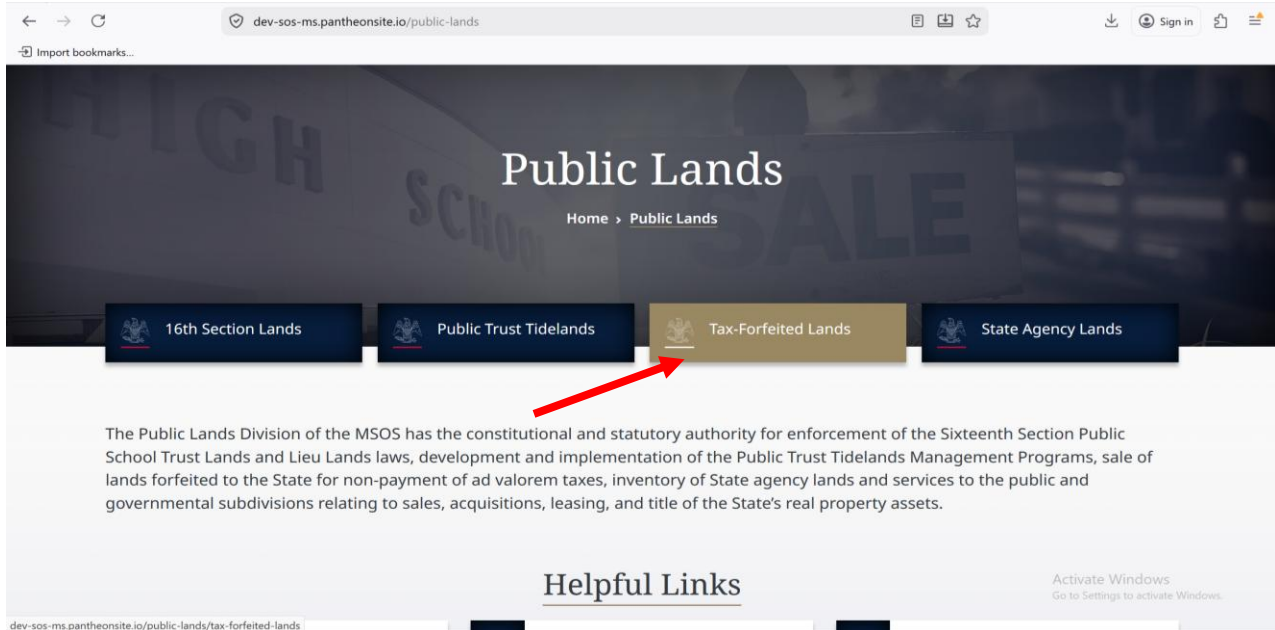
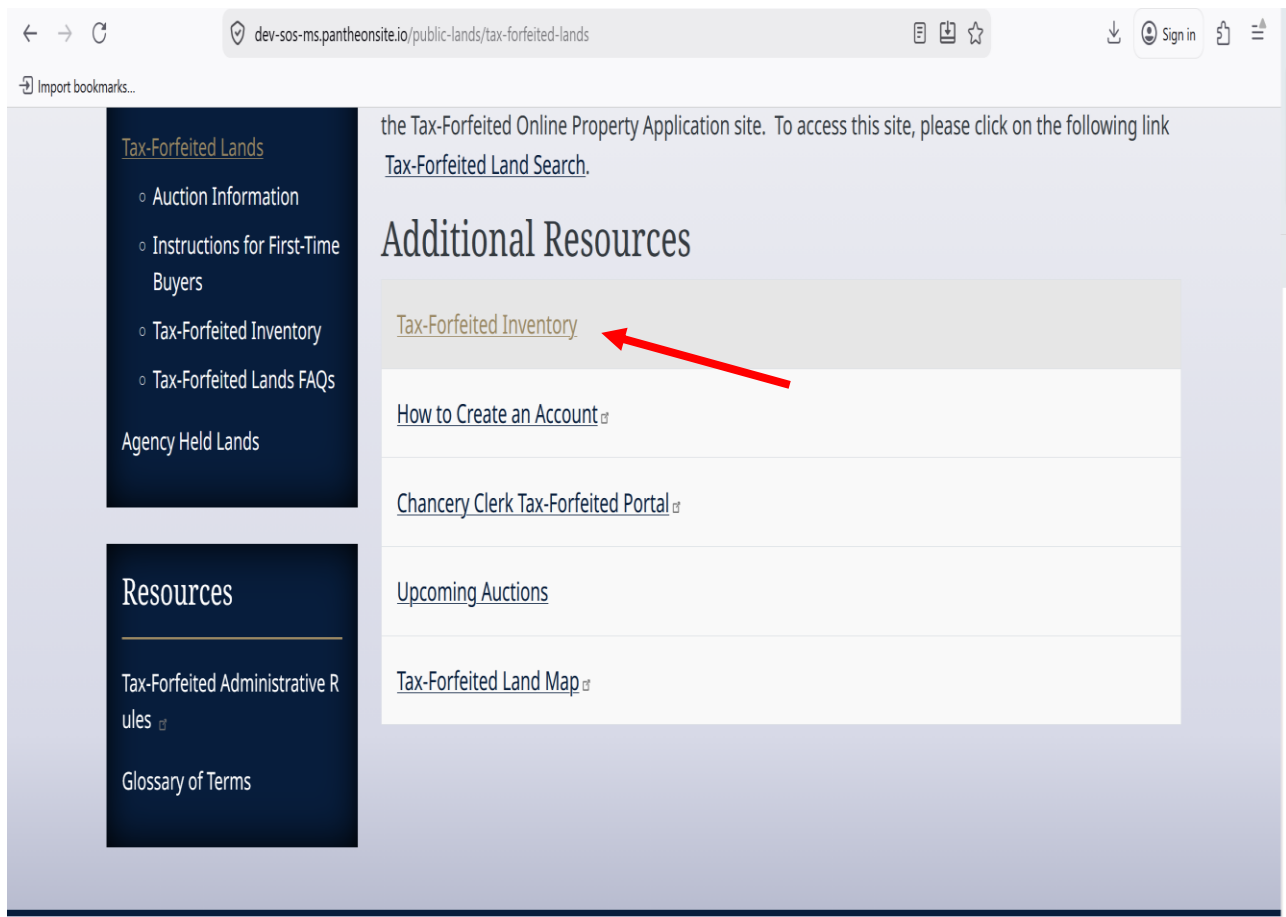


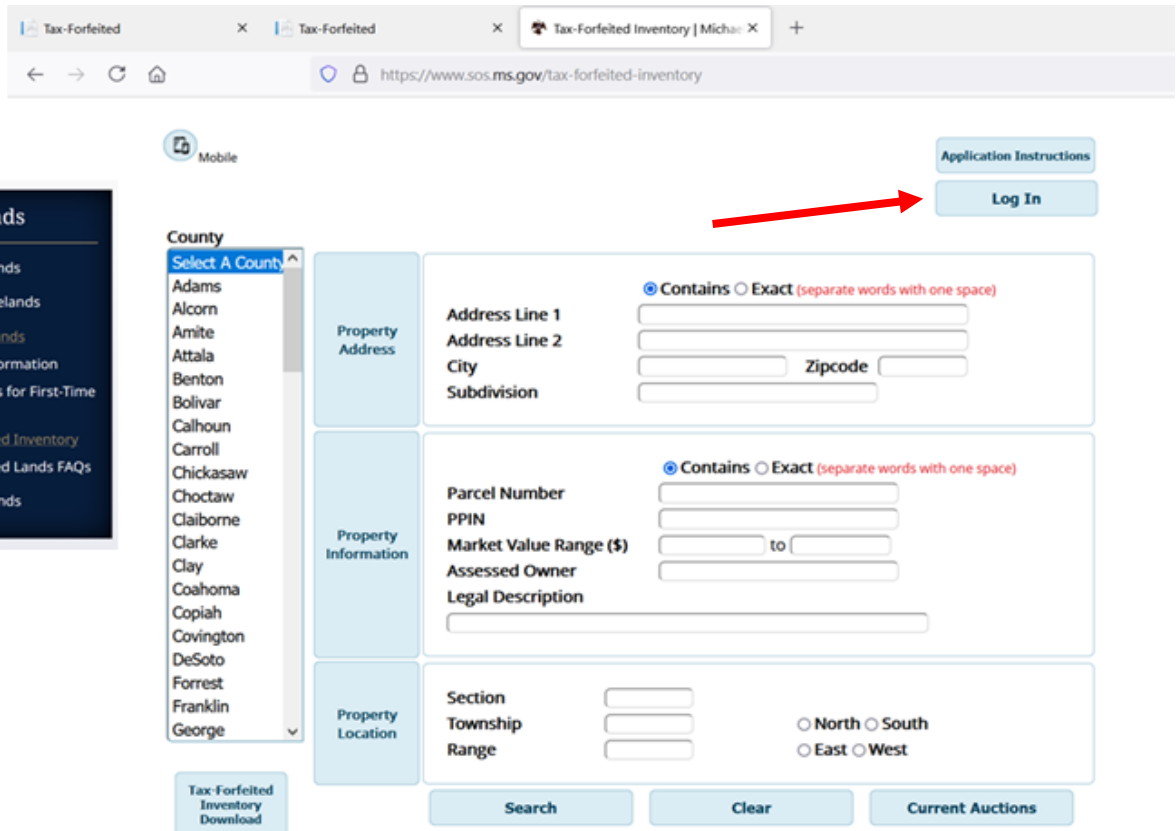
1. On the Secretary of State's website (www.sos.ms.gov), click the "Public Lands" link in the center of the menu.



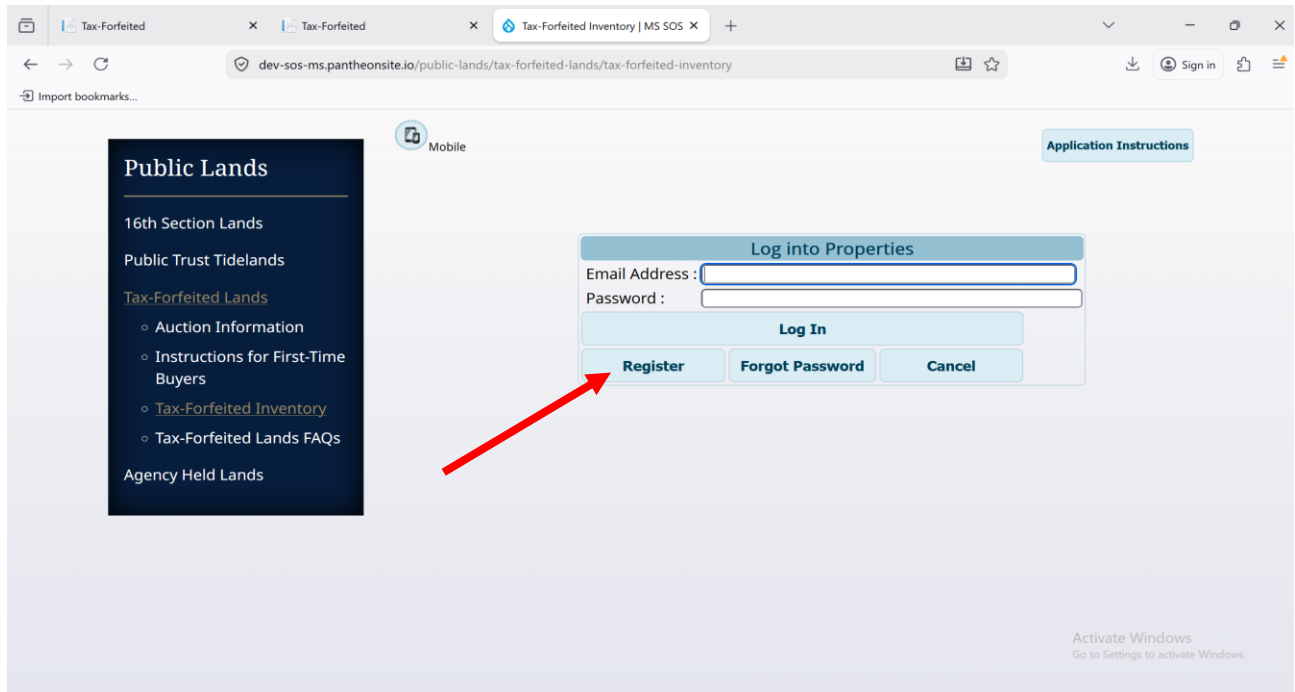
2. Click the "Tax-Forfeited Lands" link under the "Public Lands" link.

5. Click the “Register” button on the “Log into Properties” window.

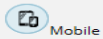
