

## **RESOLUTION**

WHEREAS, it is necessary for the Occupational Licensing Review Commission to issue a resolution regarding the approval or denial of specific rules submitted for its review:

NOW, THEREFORE, LET IT BE RESOLVED BY THE OCCUPATIONAL LICENSING REVIEW COMMISSION, that the following rules shall be known to have been approved by the Commission at a duly called meeting of its members on April 15, 2019, and may now be filed as final with the Secretary of State's Office for the inclusion in the Mississippi Administrative Code:

Rules of the Board of Examiners for Licensed Professional Counselors, as amended —

Title 30, Part 2201, Rules 1 – 9.1 – Composite Rule changes to implement HB 708 which created a new license offered by the Board which caused wholesale changes throughout the document plus additional grammatical changes were made. Approved as amended to change the word 'premise' to 'premises' in the second sentence of Rule 4.2 (B)(3); correct any typographical errors regarding a fee for retired licensees; change the definition of 'Declaration of Practice' in Rule 1.4 (M) to read "A statement presented to the Board by a P-LPC as an example of an informed consent which indicates the qualifications of the P-LPC, the counseling process, expectations, supervision of notes the competence of the P-LPC in providing services. This statement is provided to the Board. A P-LPC must provide an updated Declaration of Practice statement each time

site or supervisor changes and for each renewal of P-LPC."; and amend the rules to be consistent with statute.
