



RESOLUTION

WHEREAS, it is necessary for the Occupational Licensing Review Commission to issue a resolution regarding the approval or denial of specific rules submitted for its review:

NOW, THEREFORE, LET IT BE RESOLVED BY THE OCCUPATIONAL LICENSING REVIEW COMMISSION, that the following rules shall be known to have been approved by the Commission at a duly called meeting of its members on August 7, 2019, and may now be filed as final with the Secretary of State's Office for the inclusion in the Mississippi Administrative Code:

- Rules of the Board of Law Enforcement Officers Standards and Training - Part 301: All Chapters changed to Uniform Numbering System; Ch. 2; Ch. 6; Ch. 11; Ch. 12; Ch. 15; Ch. 16 – To change to uniform numbering system, strike out all documents not deemed as necessary rules such as applications, laws, forms, background investigation helps, contacts, addresses. To change diploma requirements, add skills updates, update reimbursement example, update refresher packet information, update constable requirements, remove outdated information on DA Investigators, remove legislation chapter.
- Rules of the State Board of Dental Examiners, *as amended* – 30 Mississippi Administrative Code Part 2301, Rule 1.7 – Provisional and Specialty Licensure; Previous administration omission of Regulation 7 addition to allow for licensure of military

personnel and for military spouse. *Approved as amended to change paragraph D. 2. (c) and E. 2. (c) to 'the applicant while on active duty is licensed to practice pursuant to that license for a minimum of two of the five years...'*

- Rules of the State Board of Dental Examiners, *as amended* – 30 Mississippi Administrative Code Part 2301, Rule 1.35 – Maintenance of Controlled Substances, Records, and Inventory; Previous administration omission of Regulation 35 addition to allow for the establishment of the Prescription Monitoring Program and to set general provisions regarding Schedule II Medications for Mississippi Dentists. *Approved as amended to change paragraph 5.B. and 5.C. to say 'one (1) day' instead of 'three (3) days'. This approval is contingent upon approval of the State Board of Dental Examiners.*
- Rules of the State Board of Dental Examiners, *as amended* – 30 Mississippi Administrative Code Part 2301, Rule 1.41 – Continuing Education; Previous administration omission of Regulation 41 that requires continuing education for dentists in prescribing controlled substances. *Approved as amended to remove 'Effective January 1, 2018' from paragraph 5.*
- Rules of the State Board of Dental Examiners – 30 Mississippi Administrative Code Part 2301, Rule 1.49 – Active Status; Previous Administration omission of Regulation 49 that defined biennial collection cycle.
- Rules of the Board of Pharmacy – Title 30 Part 3001 Article XXV Inventory Requirements for Controlled Substances; Title 30 Part 3001 Article XXV to correct inconsistencies between regulations and to allow flexibility in compliance with the regulation.

- Rules of the Board of Pharmacy – Title 30 Part 3001 Article XLIII Prescription Monitoring Program; Title 30 Part 3001 Article XLIII to require pharmacies to report to the PMP every 24 hours.
- Rules of the Board of Pharmacy, *as amended* – Title 30 Part 3001 Article XXXI COMPOUNDING GUIDELINES; Obtain statistical data on compounding; allow simple compounding, reduce burden on compounding for veterinary use. *Approved as amended to remove ‘and submit a fee as set by the Board’ from paragraph 1 A. i.*
