

## **RESOLUTION**

WHEREAS, it is necessary for the Occupational Licensing Review Commission to issue a resolution regarding the approval or denial of specific rules submitted for its review: NOW, THEREFORE, LET IT BE RESOLVED BY THE OCCUPATIONAL LICENSING REVIEW COMMISSION, that the following rules shall be known to have been approved by the Commission at a duly called meeting of its members on October 17, 2019, and may now be filed as final with the Secretary of State's Office for the inclusion in the Mississippi Administrative Code:

- Rules of the Board of Physical Therapy Title 30, Part 3101, Chapter 1 Rule 1.3.6 (c)(A-K); Removing the provisions for intramuscular dry needling manual therapy practice requirements from the definition rule from Part 3101, Rule 1.3.6 (c)(A-K) and to add the practice rule to Part 3103, Rule 3.3.
- Rules of the Board of Physical Therapy Title 30, Part 3103, Chapter 3, Rule 3.3 & 3.4; Moving the current intramuscular dry needling manual therapy rule from Part 3101, rule 1.3 (A-K) to Part 3103 Rule 3.3 with amended provisions to change the length of time it takes to complete the dry needling requirements and to renumber Part 3101 Rule 3.2 Code of Ethics to 3.4.

- Rules of the Board of Physical Therapy Title 30, Part 3101, Chapter 3, Rule 3.2; Adding new rule for telehealth practice to Part 3103, Rule 3.2 and to renumber the current Rule 3.2 in this chapter. *Approved as amended to remove 'and at least three (3) years of experience of practice as a licensed physical therapist or physical therapy assistant' from Rule 3.2 paragraph 4.b.*
- Rules of the Board of Nursing Home Administrators Title 30, Part 2701, Chapter 1, Rule 1.3 H.; This rule is being amended to revise the fee schedule of the Board.
- Rules of the Board of Nursing Home Administrators Title 30, Part 2703, Chapter 1, Rule 1.3.A.(2); This rule is being amended to allow Preceptors to apply to earn continuing education hours for precepting/training an Administrator-in-Training (A.I.T.).
- Rules of the Board of Licensure for Professional Engineers and Surveyors Rule 1; to re-organize, clarify and provide uniformity for Rule 1. Changing the ex-officio of the Board from the Secretary to the President for Council attendance. *Approved as amended to add President back to those required to furnish a surety bond in Rule 1.10.*
- Rules of the Board of Licensure for Professional Engineers and Surveyors Rule 2; to re-organize, clarify and provide uniformity for Rule 2.
- Rules of the Board of Licensure for Professional Engineers and Surveyors Rule 3; to re-organize, clarify and provide uniformity for Rule 3. Update deadline for paper and pencil examinations. *Approved as amended to change Rule 3.1 paragraph 3 to read 'An application not properly completed, not containing all of the required information, or not accompanied by the required fee will be deemed incomplete with a statement of the reason for nonapproval.' Also approved as amended to move the word 'must' after the phrase 'supporting the application' in the second paragraph of Rule 3.3.*
