EXECUTIVE ORDER NO. 1546

WHEREAS, on February 14, 2021, pursuant to the Constitution of the State of Mississippi and Miss. Code Ann. § 33-15-11(b)(17), a Proclamation was issued declaring that a State of Emergency exists in the State of Mississippi as a result of extreme freezing temperatures and severe winter weather, including snow and freezing rain beginning February 13, 2021, and continuing; and

WHEREAS, the extreme freezing temperatures and severe winter weather beginning on February 13, 2021, has limited and disrupted commercial vehicles from accomplishing their designated responsibilities creating a backlog of deliveries by commercial vehicles of essential items of commerce to customers throughout the State of Mississippi; and

WHEREAS, severe winter weather has required motor carriers and drivers to travel further distances to secure sources of fuel to meet the needs of consumers throughout the State of Mississippi creating a delay in the delivery of essential items like groceries, poultry, livestock, pharmacy items, and medical equipment; and

WHEREAS, any unnecessary delay in the delivery of such essential items to customers throughout the State of Mississippi during the State of Emergency will result in extreme hardship and threaten the public health and safety; and

WHEREAS, 49 C.F.R Section 390.23 authorizes a state governor, following the declaration of a State of Emergency, to exempt, for a period not to exceed thirty (30) days, any motor carrier or driver operating a commercial motor vehicle to provide direct assistance in providing emergency relief during an emergency from Parts 390 through 399 of Chapter 49, Code of Federal Regulations.

NOW, THEREFORE, I, Tate Reeves, Governor of the State of Mississippi, pursuant to the authority vested in me under the Mississippi Constitution, the Mississippi Emergency Management Law as amended, Miss. Code Ann. § 33-15-1 *et seq.*, 49 C.F.R. Section 390.23, and in the public interest and for the general welfare, do order and direct as follows:

- I. Any motor carrier or driver operating a commercial motor vehicle utilized for the delivery of essential items of commerce including but not limited to groceries, pharmacy items, medical equipment, goods, commodities, fuel, poultry and livestock is exempted from Parts 390 through 399 of Chapter 49, Code of Federal Regulations. This Executive Order shall be effective upon execution and shall remain in full force and effect until 5:00 p.m. on Friday, February 26, 2021, unless it is modified, amended, rescinded or superseded.
- II. Executive Order 1545 is hereby amended and extended until 5:00 p.m. on Friday, February 26, 2021, unless it is modified, amended, rescinded or superseded.
