EXECUTIVE ORDER NO. 1564

WHEREAS, on August 30, 2022, pursuant to the Constitution of the State of Mississippi and Miss. Code Ann. § 33-15-11(b)(17), I issued a Proclamation declaring that a State of Emergency exists in the City of Jackson, Mississippi and the surrounding areas of Hinds County that receive water from the O.B. Curtis Water Treatment Plant ("Plant") as a result of the total or near total loss of water pressure throughout that area; and

WHEREAS, the total or near total loss of water pressure throughout the City of Jackson and surrounding areas of Hinds County that receive water from the Plant has created a condition of disaster and extreme peril to the safety of persons and property of such a magnitude that is beyond the control of the services, personnel, equipment and facilities of the City of Jackson and Hinds County to combat; and

WHEREAS, all available local and state resources have been deployed or expended and assistance from the Mississippi National Guard is necessary to support state assistance to the City of Jackson and surrounding areas to further its response and recovery efforts.


NOW, THEREFORE, I, Tate Reeves, Governor of the State of Mississippi, pursuant to the authority vested in me by Sections 119 and 217, Mississippi Constitution of 1890, and Miss. Code Ann. Sections 7-1-5, 33-7-301 and 33-7-305, do hereby direct Major General Janson D. Boyles, Adjutant General, to order out such officers and enlisted personnel of the Mississippi National Guard as he deems necessary and requisite and for such duration as he deems appropriate to assist state and local civil authorities cope with this emergency. Major General Boyles will be in direct Command of the troops ordered to active duty and will use such equipment as may be found necessary in his opinion to accomplish the support mission. The members of the Mississippi National Guard ordered to active duty under the provisions of this Order shall be subject to the provisions, privileges and immunities of the State of Mississippi, including those governing the Mississippi National Guard. Major General Boyles is authorized to request and accept such federal funding as may be available for the Mississippi National Guard under Title 32 of the United States Code and otherwise.

FURTHER, the pay and expenses of the troops ordered to State Active Duty shall be paid as provided in Miss. Code Ann. Sections 33-7-313, 33-7-315 and 33-9-15, unless said pay and expenses are borne by the United States of America pursuant to Title 32 of the United States Code or otherwise. All costs will be reimbursed as authorized by Miss. Code Ann. Section 33-15-307(4)(g) and/or other applicable Mississippi or federal law.
