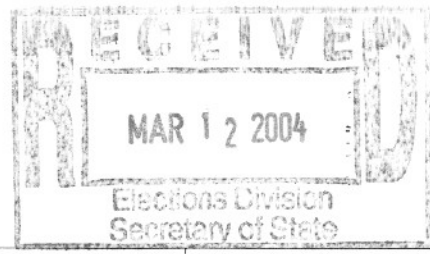


Official Recapitulation
