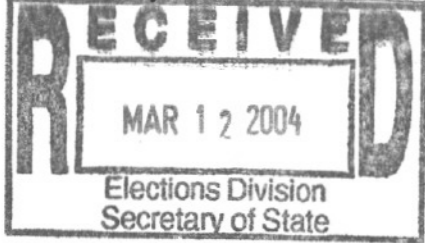


# Official Recapitulation
