

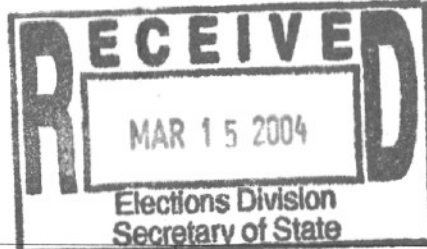
# Official Recapitulation

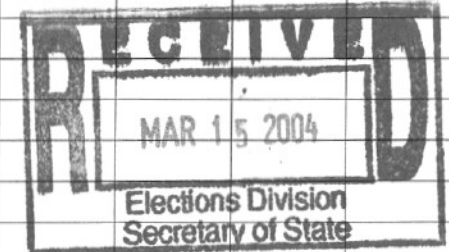

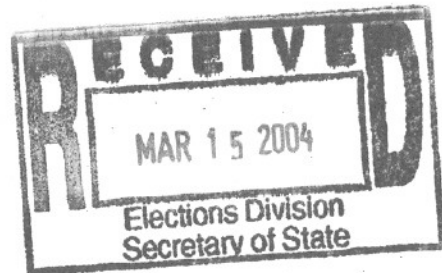
