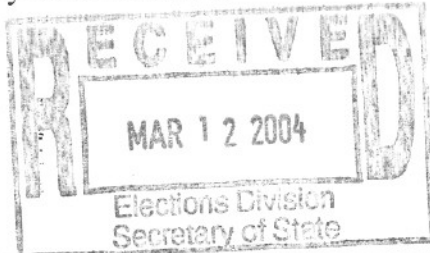


Official Recapitulation
