

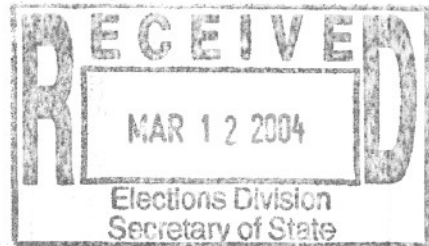
Official Recapitulation
