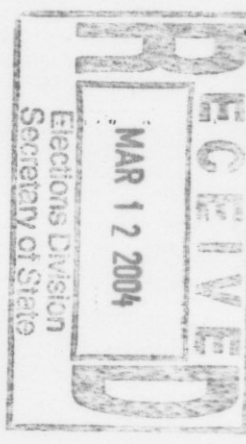


Official Recapitulation
