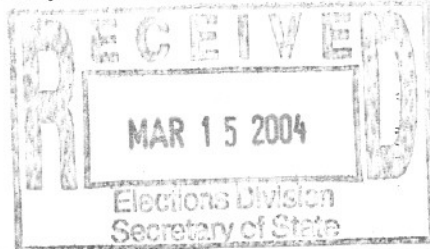


Official Recapitulation
