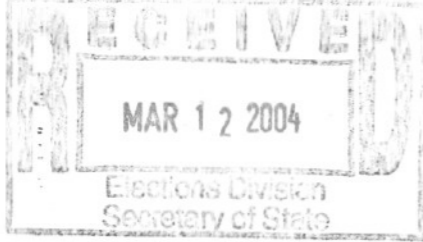


Official Recapitulation

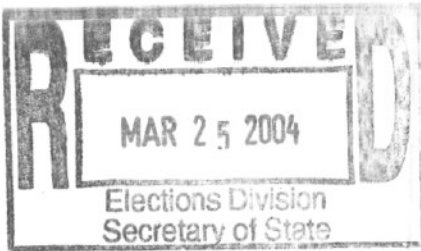
