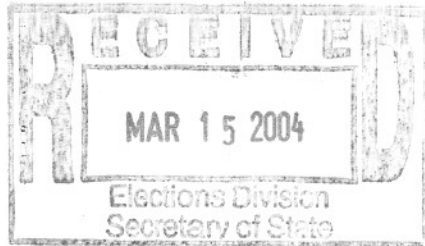


# Official Recapitulation

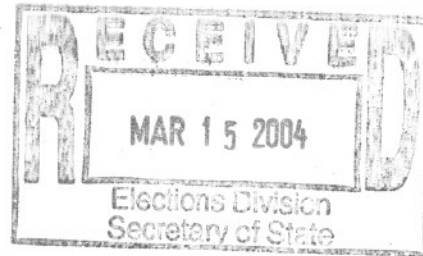
