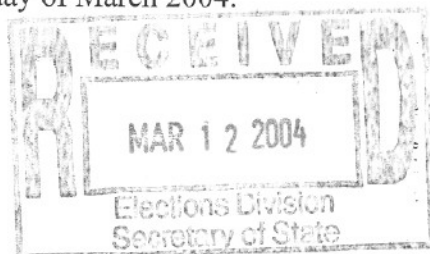


Official Recapitulation
