

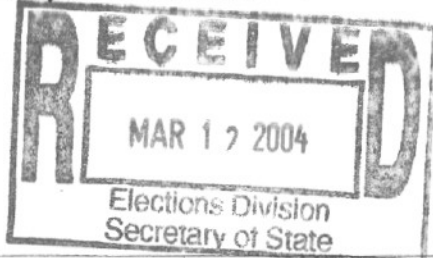
Official Recapitulation
