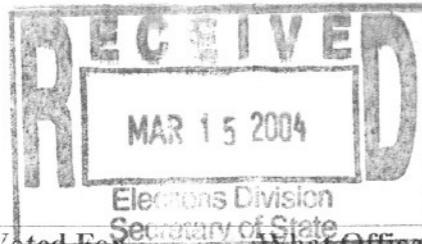


Official Recapitulation






