

2nd District



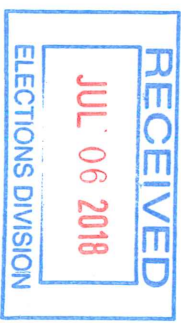
