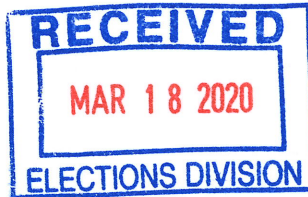


**Official Recapitulation
