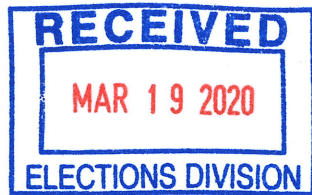


**Official Recapitulation


