



This form must be completed and returned with the certified SEMS Recapitulation (Recap) Report and your Voting System (VS) Server Election Summary Report.

1. **LT** All Memory Cards/sticks have been uploaded to the VS Server.
 2. **LT** All accepted absentee ballots have been scanned and uploaded to the VS Server.
 3. **LT** All emergency ballots have been scanned and uploaded to the VS Server.
 4. **LT** All approved regular affidavit ballots have been scanned and uploaded to the VS Server.
 5. **LT** All approved Voter ID affidavit ballots and absentee affidavit ballots have been scanned and uploaded to the VS Server.
 6. **LT** Any hand counted ballots have been manually entered into the VS database prior to final SEMS import.
 7. **LT** If not electronically importing into SEMS, all vote totals including hand counted paper ballots using the results from VS Server, have been manually entered into SEMS.
 8. **LT** The Election Summary Report has been printed from VS Server with final vote totals.
 9. **LT** The Official SEMS Recap Report has been printed by party with final vote totals.
 10. **LT** The vote totals for each candidate have been reconciled between the SEMS Recap Report and the VS Election Summary Report.
 11. **LT** The signature page of the SEMS Recap report must be signed by the officials in charge of the election.
 12. **LT** This form, the SEMS Recap report with Signature page, and the VS Election Summary report must be emailed (Logan.Witcher@sos.ms.gov) or faxed (866-757-1031) to complete the certification process.


