EXECUTIVE ORDER NO. 1579

WHEREAS, WE THE PEOPLE of the State of Mississippi shall never forget the sacrifices of the members of the American armed forces and shall always stand ready to recognize and honor those who gave the last full measure of devotion for the cause of freedom; and

WHEREAS, Mississippi mourns the passing of Chief Warrant Officer 4 Derek Joshua Abbott and Chief Warrant Officer 4 Bryan Andrew Zemek who lost their lives in the line of duty on February 23, 2024, in an AH-64 Apache helicopter crash in Prentiss County, Mississippi; and

WHEREAS, Officer Abbott was born on February 14, 1982, the son of Danny Abbott and Mary Savage, and began his distinguished military career on December 27, 2002, when he enlisted as a private in Company D, 1st Battalion, 159th Aviation Regiment, Mississippi National Guard; and

WHEREAS, in August 2006, Officer Abbott was deployed to Iraq and was recognized for exceptionally valorous achievement during air operations supporting Operation Iraqi Freedom, earning the Air Medal with Valor; and

WHEREAS, Officer Abbott married the love of his life Brandi eighteen years ago and the couple have three children Chandler, Breanna and Grayson; and

WHEREAS, Officer Abbott was a devout Christian known to his friends and family for his steadfast devotion and love of Christ, his immense love and devotion to his family, and his commitment to service in his church, in the military, in his community, and for his country, and he will always be remembered as a Forever Hero; and

WHEREAS, the words of Governor Tate Reeves reflect the thoughts and prayers of the State of Mississippi: *"I want to extend my deepest condolences to the families and friends of our fallen soldiers. We will always remember their honorable service, and we grieve with the families during this tragic time."*; and

WHEREAS, in the words of the Adjutant General of the Mississippi Army National Guard, the loss of Officers Abbott and Zemek *"is a devastating day for the Mississippi National Guard, and this accident serves as a constant reminder of the selfless service, sacrifice and commitment that our brave service men and women face while performing in the line of duty."*


NOW, THEREFORE, I, Tate Reeves, by the authority vested in me as Governor by the Constitution and laws of the State of Mississippi, and 4 USC § 7(m) do hereby proclaim a day of official mourning in the State of Mississippi in memory of Chief Warrant Officer 4 Derek Joshua Abbott and direct that all flags of the United States of America and the State of Mississippi be flown at half-staff on all buildings and grounds of the State of Mississippi and all areas under its jurisdiction beginning at sunrise and ending at sunset on Sunday, March 17, 2024, in memory of Officer Abbott. Mississippi will forever remember Officer Abbott's devotion and sacrifices for our great Nation.
